<u>Presidents Report</u>

AGM June 27, 2017

It is with mixed feelings that I present my last report as President of the Board of Directors of the Fredericton/ Oromocto Big Brothers Big Sisters Agency. I have been actively involved with the agency for over 30 years as both a Big Sister to two Littles and a Board member.

During the past eleven years I have been able to dedicate a significant amount of time to our organization because I had retired from my work with the Federal Government. It has been my pleasure to do what I could to raise our profile in the community and to raise money for this great cause. I firmly believe in our mandate of ensuring that every child who needs a mentor gets a mentor.

I leave the organization with optimism for the future but also with concern. The number of children served by our agency has not increased to keep up with the increase in our population including refugees and immigrants. We do not have a dedicated full time Executive Director, sufficient caseworkers to grow our numbers, and the sustainable finances required to run the programs needed to serve our community. BBBS has an international reputation as having an exemplary mentoring model which should help us to find businesses, foundations, government agencies, individuals who want to support us in a financial way.

Bowl for Kids Sake can still be an important yearly event that should be able to raise significant amounts of money. We need to think outside the box and find ways to grow the event here in Fredericton /Oromocto. We should talk to the Saint John office about their Bowl event. They run it over several days, have numerous gold silver and bronze sponsors, and raised over \$150,000 this year.

Rib Fest can continue to be a good fundraiser for us but it is very time consuming and is weather dependant. Also, the way the Executive Director has been using our name and reputation to fill their own coffers definitely needs to be addressed. We should have something in writing going into next year so we can get the most money possible from the event.

Our main focus should be getting sustainable funding so we can use special events as gravy instead of our meat and potatoes.

Service Delivery Overview:

Big Brothers Big Sisters supported 92 matches for children in our mentoring programs during the past year. 10 children were involved in the 2016 Summer Bunch Program. 45-50 more children and their families benefited through casework support, and one or more of the following:

- a) participation in agency activities such as the Christmas party,
- b) sponsorships for Christmas, camps, sports, events and bus passes.





Treasurer's Report Year Ended April 30th, 2017

To the Board:

For the fiscal year ended April 30th, 2017 I am pleased to announce an excess of revenues over expenses of \$18,745, bringing our cumulative total to \$23,722. It was a great result and we should all be proud of the work we did to accomplish this. This is a step in the right direction towards putting our organization on a solid financial base. However, much work still needs to be done and I still advocate towards our continuing to build a reserve fund. We are still waiting on information surrounding what the CRA will allow us to hold as a reserve fund, and once we know this we can better plan towards obtaining that target. If we are able to complete our goal of building one, it would offer us flexibility in the event of an unforeseen expense or if a large fundraiser does not have the results we were counting on.

We continue to work towards our diversification of fundraising revenues with events such as RibFest being of increasing importance as we face a headwind from a decline in the revenue from this year's Bowl for Kids' Sake. In creating this year's budget I attempted to stay conservative with our revenue expectations, providing benchmarks which we should be able meet and possibly exceed. As we look to the future we must continue to keep a close eye on our expenses and not take for granted the financial performance of last year. Together we can continue to work towards creating an organization whose going concern status is not questioned because of financial difficulties.
